President's Message

During the past two years, we have had to fight attempts to merge the LEOFF I and LEOFF 2 pension plans. Although this issue was not raised again this year, we still believe that it may be resurrected.

What did occur this year was the (late) introduction of SB 5916. This bill appears to be a knee jerk response to a couple of Seattle Times articles on the process of "spiking" (hefty salary increases just prior to retirement) which results in a higher monthly benefit for the recipient. The articles focused on worst-case scenarios – primarily high-ranking department members who were taking a LEOFF I retirement. Missing from these articles was an explanation that "spiking" was often encouraged by city managers who wanted to push top paid LEOFF I members into retirement so they could be replaced with younger officers subject to benefit packages which did not include medical coverage. SB 5916 was changed several times with several additions.

The one we were most concerned with was in section 4 of the current bill – which authorizes DRS to have responsibilities not allocated in the LEOFF I pension system. We believe that the language in this bill would open the door to usurp control of LEOFF I disability boards – and is illegal.

SB 5916 is strongly opposed by the LEOFF I community in general – and particularly by the LEOFF I Coalition. Although his bill never made it to the floor this year, we fully expect it to be reintroduced next year. This is a bad bill – and we must do everything that we can to defeat it; even DRS opposes this bill. 🐾



Twelve Long Years...

Twelve Years! Twelve long, harrowing years our Coalition has stood steadfastly by while repeated attempts have been made to open up LEOFF pension law with the intent to access and capture alleged surpluses in our members LEOFF I pensions. With the funding, support and determination of our active and retired members we have prevailed; thus far. The financial support from our members allowed us to employ legal help when appropriate to defend our system and to ensure that member's benefits were not unilaterally denied or reduced. The Coalition traveled the state during the early years to help rally members and educate one and all about the threats LEOFF I faced. That effort was much appreciated and much needed. Sadly, some of the people who were instrumental in that effort have passed on. Others have succumbed to the illnesses of old age, rendering them unable to continue the struggle. They are sorely missed. They will not be forgotten.

During those long dark years, we held fast to the value of LEOFF laws that we live under and that were designed to provide contractually agreed upon benefits to our members. Some of those benefits were challenged in courts and were found to be legally binding and appropriate. We do not look forward to having to be "reborn" as LEOFF 3 and having, once again, to defend hard-won benefits in the courts.

Nor do we look forward to ill-designed proposals to merge our system with any others. We feel those efforts

held little but increased risks with no safe protections and without representation within the leadership of those controlling systems. Legislators considering such legislative changes should have the common decency to deal directly with our LEOFF I members, not those wishing to force unwanted change upon us.

Which brings us to the "here and now." It appears we have survived another legislative session. This publication does not provide adequate space to revisit the long, tortured history of our LEOFF system. Suffice it to say that it has been challenged from the outset by legislative failure to provide agreed upon contributions during the early years. That failure to provide actuarially recommended contributions by the State led directly to the formation of LEOFF 2 and the closure of LEOFF I to new members. Regrettably, that failure by the state was predicted to lead to our financial collapse.

Twenty short years later our system was alleged to be so over-funded that an enormous battle was fought to access that alleged surplus. What was predicted to bankrupt the state has instead become a target for other state organizations and legislatures seeking funding for other uses.

We stand ready to meet challenges to our system and to deal appropriately within legal channels to threats we perceive to our member's contractual benefits. And, please, remember this: we...are...not...dead...yet! Any who wish to deal with our members' LEOFF I benefits will deal with a determined and energized membership.
